## 2021–2022 PWK Program Calendar Additional Changes

Due to a shipping backlog at China's ports, combined with the continued interruptions at U.S. ports and landside congestions, the remaining 2021–2022 PWK promotion start dates have been further delayed. As such, BKC and RSI have made adjustments to the PWK Marketing Calendar to help mitigate any potential toy outages.
